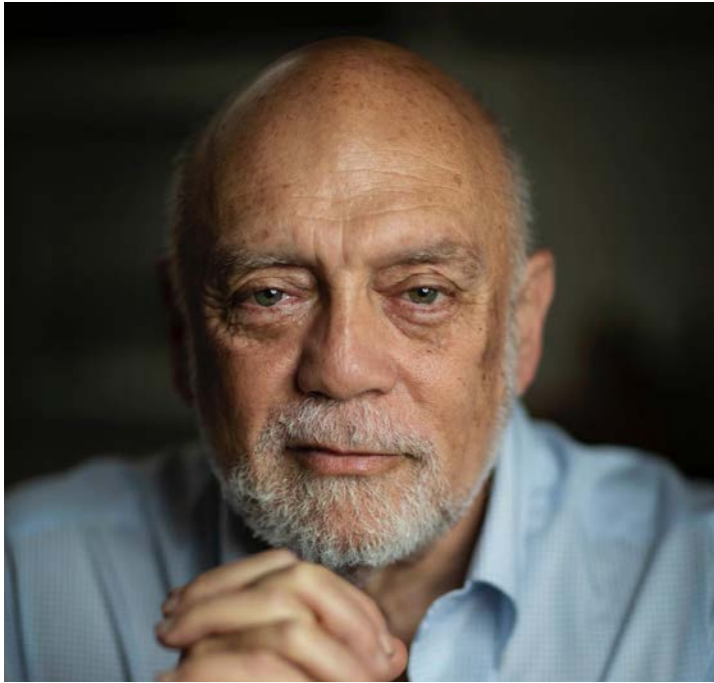

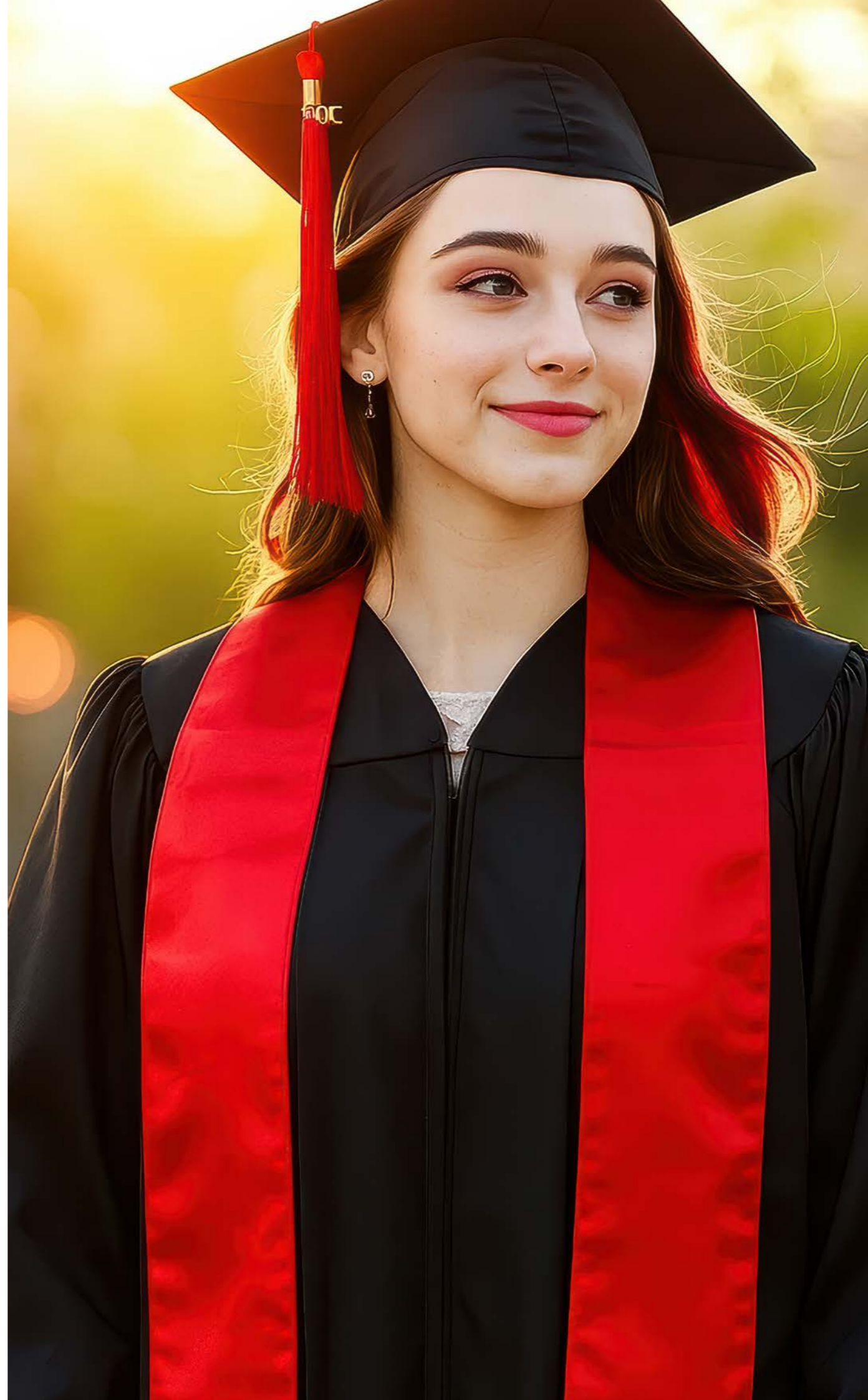

# How we Teach



## Our Approach to Learning

GCA's teaching methodology integrates face-to-face and online formats to deliver core theoretical content, ensuring flexibility and accessibility for diverse student cohorts. Synchronous and asynchronous delivery introduces foundational concepts, frameworks, and discipline-specific knowledge, providing the intellectual scaffolding you require before engaging in applied learning. This is complemented by structured tutorial sessions in which you actively consolidate and extend your understanding through purposefully designed activities, including case study analysis, digital simulations, and real-world scenarios.

## Practical Learning

Case studies situate abstract theory within authentic professional contexts, encouraging you to critically examine problems, evaluate evidence, and justify reasoned decisions. Simulations further deepen engagement by replicating complex, dynamic environments in which you can experiment, observe outcomes, and refine your thinking in a low-stakes setting.

Structured activities and real-world scenarios then bridge the gap between academic knowledge and professional practice, challenging you to apply, adapt, and synthesise what you have learned in response to the kinds of ambiguous, multifaceted challenges you are likely to encounter beyond the classroom. Together, these learning and teaching strategies position you as an active participant in the co-construction of knowledge rather than a passive recipient of information.

## How We Assess

GCA is committed to ensuring that all assessments are valid, reliable, and fair. Assessments are designed and conducted in a manner that accurately measures your achievement against the intended learning outcomes.

In each unit, you will encounter a combination of formal learning tasks, project-based assessments, and formative activities. These are sequenced deliberately to build your knowledge and capabilities progressively across the trimester, so that each stage of the assessment prepares you for the next and supports the achievement of the unit's learning outcomes.

Formative activities - including in-class tasks, diagnostic quizzes, peer review, and feedback checkpoints - are designed to identify gaps, guide your revision, and develop the analytical and professional skills that formal assessments require. Project-based assessments unfold across multiple stages, with each submission building on the previous one, mirroring the way complex professional challenges are approached in practice: iteratively, collaboratively, and with sustained critical engagement.

You may also be assessed through written assignments, presentations, performance tasks, and portfolio development, depending on the requirements of each unit. Across all assessment types, the emphasis is on demonstrating genuine understanding, well-reasoned argument, and the ability to apply theoretical knowledge to authentic professional contexts.

## How to Apply:

You must be able to demonstrate the qualifications, skills and attributes during your application that establish your eligibility and foundational capabilities necessary for academic success including English language proficiency. Full information regarding admissions criteria is available in our Student Selection and Admissions Procedure available at [www.gca.edu.au](http://www.gca.edu.au)

## Undergraduate:

Our undergraduate programs welcome both domestic and international students. To gain admission to any course offered by GCA at AQF levels 5-7 (diploma, associate degree, and bachelor's degree), applicants must have completed Australian high school studies, Australian vocational studies, or equivalent overseas studies. Additionally, applicants must meet the minimum English language requirements, as demonstrated by test results obtained within the last two years. For more details, please refer to our Student Selection and Admissions Procedure, available on our website at [www.gca.edu.au](http://www.gca.edu.au), or contact our admissions team.

## Postgraduate:

Our postgraduate courses are available to both domestic and international students. To be eligible for admission to the Graduate Certificate (AQF level 8), applicants must have at least five years of relevant professional management or business-related work experience. To be eligible for entry to the Graduate Diploma, applicants must demonstrate completion of a Graduate Certificate (AQF level 8) qualification. For eligibility into the MBA (AQF level 9) course, applicants must possess a Bachelor's Degree (AQF level 7) or a postgraduate award from GCA (AQF level 8), or an overseas university qualification equivalent to a Bachelor's Degree (AQF level 7) or higher.

Additionally, all postgraduate courses require a minimum level of English language proficiency, which must be evidenced by test results obtained within the last two years. Please see the Student Selection and Admissions Procedure for more information on all admissions requirements.
