The per-trimester cost is calculated based on the amount of enrolled units per trimester (three times a year) over three years. Fees can be paid in advance or by the specified due date via credit card/debit card (Mastercard & Visa Only).

General Information for Overseas Students

- Students on a student visa must be enrolled in a full-time course, which means a standard study load of three units per trimester, totalling eight units per year.
- Students are responsible for purchasing textbooks and should budget for them.

Confirmation of Enrolment (CoE) Fee (Visa sub-class 500)

The Student's CoE Fee consists of two (2) components:

- All Providers registered on the Commonwealth Register of Institutions and Courses (CRICOS) are required, under Section 23 of the Education and Services for Overseas Students Act 2000 (the ESOS Act) and Section 8 of the Education Services for Overseas Students (Registration Charges) Act 1997, to pay an Annual Registration Charge (ARC). The ARC comprises a base fee, a fee for each course registered on CRICOS, plus a student enrolment component. This is calculated based on the total number of overseas students enrolled in each course who hold student visas.
- Administrative and processing costs of maintaining the accuracy and completeness of the Commonwealth Government's Provider Registration and International Students Management System (PRISMS).

CoE Fee:

- If the course duration is 2 years, then \$65.00
- If the course duration is 3 years, then \$97.50

Students who are approved to have their CoE reduced due to credit transfer, or who are approved to have their CoE extended, will need to pay these CoE fees as part of the approval process. All Fees can be paid by: Credit Card/Debit Card (MasterCard & Visa Only) (in keeping with best industry practices, no cash payments will be accepted). Verification of Enrolment (VoE) Fee (Non visa sub-class 500)

All eligible students will be provided with a Verification of Enrolment (VoE) that confirms their offer of study with UBSS. Students are required to accept the offer in writing. On acceptance of an offer, international students will pay the administrative and processing cost (VoE Fee) of maintaining the accuracy and completeness of the Commonwealth Government's Provider Registration.
